Page 1 Waterville Valley Planning Board Summary of the Minutes for the Regular Planning Board Meeting Held on May 10, 2018 **MOTION:** The Planning Board interprets Zoning Ordinance, Section K, Paragraph 3, "Existing Uses and Non-Conforming Uses" as adopted on March 2018, to mean every sign lawfully in place at the time of the adoption of the referenced regulation may continue to exist and continue to be maintained in form and color, or replaced in kind, that is of the same sign design, meaning color, line, shape, texture, space, form, unity/harmony and balance. It shall be noted that the changes in wording only are excluded.
