## **Public Hearing-Proposed Zoning Amendments**

The Planning Board opened the Public Hearing for two proposed Zoning Amendments at 8:10 am. Amendment No. 1 rezones town-owned lot 105-1032C from the Village Commercial district to the Greenbelt district. Irit Levy from the Conservation Commission was in attendance and stated that they were in favor of Amendment No. 1. T. Waite asked if the town would still be able to place a sediment pond on lot 105-1032C if it were rezoned to the Greenbelt district. T. Bamford clarified that zoning does not affect the town's use of the property for governmental purposes. Amendment No. 2 relocates "Short Term Rental" entry within the table of uses contained in Article IV. Section J. There was no public comment on Amendment No. 2. The Public Hearing was closed at 8:17 am.
