## **Planning Board Rules of Procedure**

### **Site Plan Regulations**

Town staff updated the site plan regulations to include requirements for stormwater management, and the Board reviewed the changes. T. Bamford suggested making additional updates in response to RSA changes. The Board asked town staff to work with T. Bamford to make the changes.

### **Snow's Mountain Special Zoning Area**

M. Decoteau reported that there is a map delineating the Snow's Mountain Special Zone. The town will import it into the GIS system once it is received from the engineers, and it will be put on the tax maps for 2023.
